§ 1 Subject matter

Hierl & Müller GbR enables the user to access the e-kurier.net courier exchange during the licence agreement period. e-kurier.net is a platform through which authorised users exchange information on shipping space and gain access to further information in the courier sector.

§ 2 Trial period

New users will receive a **trial period free of charge** by Hierl & Müller GbR for a certain period. This trial period starts on the day of signing the contract followed by two full months.

Your free of charge trial period will thus end on _____

The contract will validate on this agreed final day of the trial period, if the user has not canceled this agreement in writing prior to that date.

§ 3 Period of licence agreement

The agreement will come into force on _____

The duration of the licence agreement is initially fixed at **6 months**, which means until _____

None of the parties to the agreement shall be able to cancel the agreement before it comes into force nor during these 6 months. After 6 months have expired, the contract is automatically renewed with the period of your choice (**§ 4**), if not cancelled in writing at least one month before date of expiry. From this point the agreement can be cancelled at the end of each quarter at four weeks notice.

§ 4 Subscription fee

The subscription fee **per month is € 60,00 € ex VAT**. The subscription fee is always due in advance for the minimum period of 3 months. Due date is the first day of the month in which the contract begins, and afterwards according to the period chosen below.

As an alternative the user can choose to subscribe for 1 or 2 years with advance payment. This will result in 7,5 % reduction for the one year subscription and 15 % reduction for the two year subscription.
