**§ 1 Subject matter**

Hierl & Müller enables the user to access the e-kurier.net courier exchange during the licence agreement period. e-kurier.net is a platform through which authorised users exchange information on shipping space or freights and gain access to further information in the courier sector.

The decision according that is exclusively within our discretion. Multiple payment obstructions or deterioration in credit assessments may cause a withdrawal of the arrayed right as a safeguard for others. The deactivation of the above mentioned right does not entitle the user to claim for an extraordinary termination of the contract.

**§ 2 Trial period**

New users will receive a trial period free of charge by Hierl & Müller for a certain period. This trial period starts on the day of signing the contract followed by two full months.

From this point the agreement can be cancelled prior to a term of 4 weeks before the end of current term.

**§ 4 Subscription fee**
